



Procore

Manage lien waivers directly from your Procore dashboard. Sync with Procore Construction Financials or your existing accounting software to complete the cycle and process payment.

Intuit QuickBooks

(QuickBooks Enterprise, QuickBooks Desktop, QuickBooks Online)

Use bills, invoices and payments from your QuickBooks account to generate, send, and keep track of lien waivers. Do it all from our centralized Built for Construction real-time dashboard.

Sage (Sage 300 CRE, Sage 100 Contractor)

Excel/CSV

Import your Excel data into the Built for Construction platform, and utilize our electronic program to complete the lien waiver cycle quickly and efficiently.

Xero

Use existing accounting data in your Xero account to create, send and track conditional and unconditional lien waivers. The bills, invoices and payments you've entered into Xero will inform the documentation you generate and collect in B4C.

DocuSign

Guarantee signatures on your lien waivers with our DocuSign integration. You can request signatures and/or notarizations directly from your DocuSign account, and track their progress in your B4C dashboard.

Notarize.com

By seamlessly integrating Notarize.com to your Lienwaivers powered by Built account, send a lien waiver out for electronic signature and notarization. Your subcontractors and vendors simply receive an email with a link to notarize via the FaceTime-like video call.


